To: All LLRIB Departments, Communities, Band Businesses and all Corporate Entities to which LLRIB is a major shareholder

Re: General Election March, 2017, Eligibility – no outstanding debt to LLRIB

This is to inform you that the Regulations for the General Band Election, 2017 include the following:

***“Conflict of Interest means that the candidate has no debt outstanding and remaining unpaid to the Lac La Ronge Indian Band, including Band entities, businesses and corporations to which the Band is the majority shareholder.”***

Therefore, Band members are not eligible to run for office in the 2017 LLRIB General Election if they owe money to the Band or have an outstanding debt to the Band. As per the attached BCR, your department/business/corporate entity is required to provide a list of all Band members that have an outstanding debt to the Lac La Ronge Indian Band, any of its corporations and/or entities as per the BCR.

Please forward this list to my office as soon as possible and no later than March 10, 2017. I will ensure that it is submitted to the Chief Electoral Officer, Milton Burns.

DO HEREBY RESOLVE:  
DÉCIDE, PAR LES PRÉSENTES:

**WHEREAS** the Lac La Ronge Indian Band is holding a General Election for a Chief and twelve Councillors on March 31, 2017, and;

**WHEREAS** the Chief and Council have established Election Regulations under the Election Act prohibiting candidates from running for election if they are in "conflict of interest", requiring that the candidate has no debt outstanding and remaining unpaid to the Lac La Ronge Indian Band.

**BE IT RESOLVED** that the Chief and Council of the Lac La Ronge Indian Band direct the Executive Director to provide a list of Band members that have a debt outstanding and unpaid, to the Chief Electoral Officer before Nomination Day and no later than March 10, 2017; and;

**BE IT FURTHER RESOLVED** that a list be provided by each of the Band Departments, Self-Administered Communities and the Band Businesses, including corporate entities to which the Band is a majority shareholder (Indian Child & Family Services Inc., La Ronge Health Services Inc. and Kitsaki Management Limited Partnership) to the Executive Director.

**BE IT FURTHER RESOLVED** that those in such list be disqualified from running for office unless their debt to the Lac La Ronge Indian Band is paid on or before Nomination Day March 10, 2017.
