## COVID-19 Emergency Measures By-Law

**WHEREAS** the potential spread of the novel coronavirus causing the disease COVID-19 requires urgent measures be taken to protect the health of residents of Lac La Ronge Indian Band reserves:

**AND WHEREAS** section 81(1)(a) of the *Indian Act*, RSC 1985 c I-5 authorizes Council to make by-laws for the purpose of providing for the health of residents on the reserve and preventing the spreading of contagious and infectious diseases;

**AND WHEREAS** section 81(1)(p) of the *Indian Act*, authorizes Council to make by-laws for the removal and punishment of persons trespassing on the reserve or frequenting the reserve for prohibited purposes;

**NOW THEREFORE** the Council of the Lac La Ronge Indian Band enacts as follows:

1. This by-law may be cited as the Lac La Ronge Indian Band *COVID-19 Emergency Measures By-law*.
2. In this by-law:
  - a. **Approved Purpose** means the purposes set out in section 3;
  - b. **Council** means the Council of the Nation;
  - c. **Nation** means the Lac La Ronge Indian Band;

- d. **Reserve** means reserve lands set aside for the use and benefits of the Nation, and includes the following communities:
  - i. Lac La Ronge Indian Reserve #156 (Includes: Far Reserve, Fairchild Street and Bell's Point)
  - ii. Kitsaki Indian Reserve #156B (Includes: Morin's Hill, Charles Street, Jack Pine, 101, Bigstone and Big Rocks)
  - iii. Potato River Indian Reserve #156A
  - iv. Little Hills Indian Reserves #158, 158A, 158B
  - v. Four Portages Indian Reserve #157C
  - vi. Fox Point Indian Reserves #157D and 157E
  - vii. Sucker River Indian Reserve #156C
  - viii. Grandmother's Bay Indian Reserve #219
  - ix. Stanley Mission Indian Reserves #157 and 157A (Includes: Nistowiak Falls)
  - x. Morin Lake Indian Reserve #217 (Includes: Hall Lake and Sikachu Lake)
  - xi. Little Red River Indian Reserves #106C and 106D
  - xii. Bittern Lake Indian Reserve #218
  - xiii. Old Fort Indian Reserve #157B
- e. **Resident** means a person with permission to occupy or possesses a dwelling located on Reserve or who ordinary resides in a dwelling located on Reserve;
- f. **Prohibited Purpose** means any purpose other than an Approved Purpose; and
- g. **Security** means a person retained by the Nation who has been authorized by Council to monitor compliance with this by-law.

DO HEREBY RESOLVE:  
DÉCIDE, PAR LES PRÉSENTES:

3. Access to the Reserve by non-Residents shall be permitted only for the following Approved Purposes:
  - a. maintaining critical infrastructure and/or providing essential services;
  - b. providing health care and/or distributing medicine;
  - c. delivering necessary supplies such as food, water, clothing, and fuel;
  - d. the administration and governance of the Nation; and
  - e. caring for a Resident who is a close family member.
4. Where a non-Resident gives at least 24 hours notice of their intention to access the Reserve to the Band Manager, the Band Manager:
  - a. shall have the absolute discretion to decide whether a non-Resident's purpose for accessing the Reserve is an Approved Purpose;
  - b. may approve access to Reserve in advance; and
  - c. shall inform the non-Resident and Security of their decision.
5. Where a non-Resident gives less than [24 hours] notice of their intention to access the Reserve, Security shall have the absolute discretion to decide whether the non-Resident's purpose for accessing the Reserve is an Approved Purpose.
6. Every non-Resident accessing the Reserve for a Prohibited Purpose is subject to immediate removal.

- 8. This By-law will remain in force until the earlier of these events:
  - a. Council repeals it; or
  - b. Saskatchewan declares that physical (social) distancing is no longer a necessary or recommended measure to deal with the Covid-19 virus.
