Re: Precautionary Boil Water Advisory Notice for Kitsaki IR 156 B (Morin's Hills and Rock's Subdivision) La Ronge.

Dear Chief Tammy Cook-Searson:

Due to construction work on the Kitsaki W&S Servicing Project, the water supply will be shut down to some houses and public buildings on Kitsaki IR 156 B (Morin's Hills and Rock's Subdivision) for 2 – 4 hours and as a result the drinking water supply will be affected to the following houses and public buildings.

**Houses:** 1701, 1702, 1704, 1705, 1801, 1802, 1901, 1902, 1903, 1904, 2001, 2002, 2003 and 2004.

**Public Buildings:** Kitsaki Hall, Health Services and Health Administration.

Please inform your community that a Precautionary Boil Water Advisory will be in effect on above mentioned houses and public buildings from immediately upon receipt of this notice.

Follow up work on the problem is in progress.
